In the Law No. 6698 on Protection of Personal Data ("KVK-PPT-Law"), personal data holders (hereinafter referred to as "the Applicant"), who are defined as the relevant person, have been entitled to make certain requests regarding the processing of their personal data in Article 11 of the KVK (PPT) Law.

Pursuant to the first paragraph of Article 13 of the KVK (PPT) Law; the applications to be made to our company, which is the data responsible, regarding these rights should be sent to us in writing or by other methods determined by the Personal Data Protection Board ("Board").

Within this framework, the applications to be made in writing to our company shall be printed out and;

- By the applicant's personal application,
- Through a notary public,
- By the applicant, it can be signed with a 'secure electronic signature' defined in the Electronic Signature Law No. 5070 and sent to the registered e-mail address of the company.

In accordance with paragraph 2 of Article 13 of the KVK (PPT) Law, your applications shall be replied within thirty days from the date we receive your request according to the nature of the request. Our responses shall be sent to you in writing or electronically in accordance with the provisions of Article 13 of the relevant KVK (PPT) Law.
